## YOUR RIGHTS

**Under the Nigerian Data Protection Regulation (NDPR)**, you have several rights about your personal data. This policy has been designed to uphold your rights where ICMG act as a data processor:

- Right of access you have the right to request a copy of the information that ICMG holds about you.
- Right of rectification you have a right to correct data that ICMG holds about you that is inaccurate
  or incomplete.
- Right to be forgotten in certain circumstances you can ask for the data ICMG holds about you to be erased from ICMG's record.
- Right to restriction of processing where certain conditions apply, you have a right to restrict the processing of certain data about you.
- Right of portability you have the right to have the data ICMG holds about you transferred to another organization.
- Right to object you have the right to object to certain types of processing such as direct marketing.
- Right to object to automated processing, including profiling you also have the right not to be subject to automated processing or profiling.
- Right to judicial review if ICMG refuses your request under rights of access, ICMG will provide you with a reason to why. You have the right to complain as detailed below.



### YOUR RIGHT TO COMPLAIN

If you wish to make a complaint about how your personal data is being processed or how your complaint has been handled, you have the right to lodge a complaint directly to ICMG's in-house data officer or with the supervisory authority.

If ICMG is unable to help, or you are not satisfied with our response, you also have the right to lodge a complaint with the National Information Technology Development Agency (NITDA).

#### WHAT DATA DO ICMG COLLECT FROM YOU?

By expressing an interest in our services, visiting our websites or registering to use our service, ICMG may collect personal information from you.

- Contact information such as name, company name, address, phone number and email address.
- Financial information such as billing name, billing address and credit/debit card details.
- **System information** such as IP Address, browser type and version, and operating system relating to information gathering tools such as cookies.
- Other information such as the number of people within your organization using our service.

#### HOW ICMG USE YOUR DATA

The data ICMG collects is used to educate and inform customers about our product and to improve ICMG's service. ICMG may also collect personal information about our prospective and existing customers, employees, vendors, and service providers.



The information collected is used to provide services to our customers. These may include but not limited to any of the following:

When processing your personal information for our legitimate interests, ICMG considers and balances any potential impact on you - both positive and negative and your rights under data protection laws.

Our legitimate business interests do not automatically override your interests. As such, ICMG will not use your personal data for activities where our interests are overridden by the impact on you, unless ICMG has your consent or are otherwise required or permitted to by law.

## SUB-PROCESSORS - Who is a sub-processor?

In summary, a sub-processor is a third-party company engaged by ICMG to assist with data processing. ICMG sets a high standard in selecting sub-processors to ensure that they are secure, maintain strict privacy policies and adhere to confidentiality practices in processing data.

ICMG may share your data with these companies to provide services on you and on your behalf. These service providers, under contractual obligations, will use your personal information only as necessary to provide the requested services to us. ICMG will not sell, rent, or trade any information with third parties for promotional or marketing purposes.

The use of our service requires the sharing of data with sub-processors which are subject to rigorous privacy statements. To use our service, you must agree with our use of sub-processors.

#### **BILLING**

ICMG uses a third-party service provider to process orders. These third-party services are not permitted to store, retain, or use any billing information provided by us.

## **DISCLOSURE**

If required by law or if disclosure is necessary to protect our rights and/or to comply with judicial proceedings, court order, or legal process, ICMG reserves the right to disclose any relevant information.

#### COMMUNICATION

When you provide information through one of our webforms or other avenues, ICMG might provide you with further information about our services. You can manage your subscription preferences at any time and unsubscribe from this information.

Should you request information from us, ICMG will use the data you provide to process this request. For example, by completing our *'Access request form'*, ICMG will get a better understanding of your requirements.

ICMG may use information you provided to contact you to further discuss your interest in our services and to send you information regarding us and our affiliates. ICMG will only process the information you provide on the grounds of legitimately meeting your requirements.



To consistently provide an expected level of service, ICMG may also use information collected to update, expand and analyze our records to create a more befitting service for you.

#### **KEEPING YOUR DATA UP-TO-DATE**

ICMG may retain your information for a period consistent with the original reason it was collected. Upon entering into an agreement with us, ICMG reserves the right to store and use your information. Upon termination of the agreement, ICMG would keep your information for required legal reasons.

As a customer, you have the right to request to review, correct, delete or otherwise modify any of the personal information you may have previously provided to us, at any time. As a user of our product, you may generally update information wherever necessary. To update your billing information or terminate your agreement with us, you can contact us. For other requests: erasure, access, portability, rectification, and objection, your requests will be addressed within thirty (30) days.

#### YOUR DATA

ICMG's customers submit data and information, whether electronically or by other means, to us for processing purposes. ICMG will not review, share, alter or distribute this data unless otherwise requested by law. ICMG only accesses your data only for the purposes of continuing to provide our services or to prevent or address any service or technical problems.
